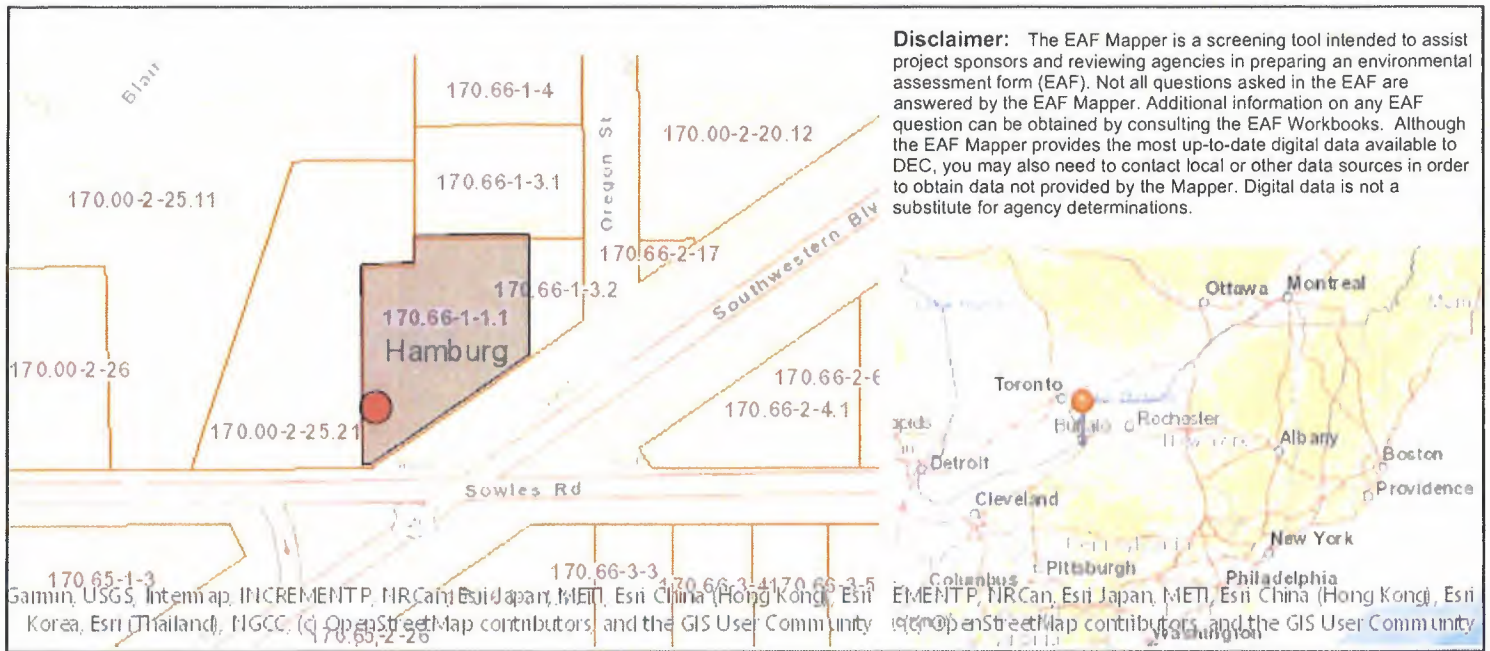

<p>The Project Sponsor is proposing to build a vehicle towing lot on a 0.5+/- acre lot at 3600 Sowles Road, Town of Hamburg, SBL No. 170.66-1-1.1. An existing single family home on the property will be demolished, existing detached garage will remain. Site improvements include new paving in front, millings in rear, site grading, fencing, landscaping and storm drainage. The zoning classification is C2 - General Commercial. The proposed project ("action") includes all required discretionary approvals. A layout of the proposed towing lot is depicted on the attached Concept Plan CP-101. The proposed project is an "Unlisted Action" pursuant to the State Environmental Quality Review Act and the implementing regulations promulgated by the New York State Department of Environmental Conservation (collectively "SEQRA") since the project will not cross any of the applicable thresholds for a Type 1 action.</p>
