DISTINGUISHING FEATURES OF THE CLASS: The work involves maintaining greens, tees, and fairways of a golf course. Under the general supervision of a higher-ranking employee the incumbent is responsible for the maintenance and care of the golf course. Supervision is exercised over a number of maintenance personnel assigned to the golf course. Does related work as required.

TYPICAL WORK ACTIVITIES:

Makes daily inspections of the golf course to note condition, determines action to correct faults;
Maintains greens, tees, and fairways in playable condition by mowing, top dressing, reseeding and fertilizing greens; Exercises the proper control over weeds, fungi, and insects using standard chemicals and procedures for the cure and prevention of grass disease and weeds;
Requests supplies and equipment from supervisor; keep records and prepares reports of activities;
Performs work on the maintenance of golf course equipment and special assignments;
Supervises and participates in maintenance and construction projects on golf-related facilities.

FULL PERFORMANCE KNOWLEDGES, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Thorough knowledge of modern methods, materials and equipment as used in greens keeping and grounds maintenance of a golf course; thorough knowledge of the recognition and treatment of common grass diseases; through knowledge of the methods of weed and insect control; ability to follow detailed oral and written instructions; ability to get along well with others; good judgment; initiative; resourcefulness; capable of performing the essential functions of the position with or without reasonable accommodation.

MINIMUM QUALIFICATIONS:

- A) An associate degree in Horticulture or related field and three (3) years of experience in grounds maintenance activities at a golf course which included the detailed care and upkeep of golf greens; or:
- B) Graduate of high school or equivalency diploma and five (5) years of experience in grounds maintenance activities at a golf course; at least two (2) years of which included the detailed care and upkeep of golf greens; or
- C) An equivalent combination of training and experience as defined by the limits of (A) and (B).

SPECIAL REQUIREMENTS:

1. Candidate must be New York State Certified as a Commercial Pesticide Applicator at time of appointment; and
2. Possession of a valid New York State Class D (minimum) Driver's License at the time of appointment and throughout duration of employment in the position.
